1. BACKGROUND

Ministry of Panchayati Raj (MoPR), Govt. of India launched Panchayat Empowerment and Accountability Incentive Scheme (PEAIS) in 2005-06. So far, under the scheme States/UTs have been awarded on the extent to which they have devolved funds, functions and functionaries (3Fs) to Panchayats. From 2011-12, this scheme has been enlarged to cover incentivization of Panchayats based on performance indicators as well.

The guidelines of PEAIS is available on the website of Department of Panchayati Raj,GoUP (www.panchayatiraj.up.nic.in).

As per the PEAIS guidelines, a set of indicators, questionnaire and marking scheme has been prepared by DoPR (Department of Panchayat Raj, Uttar Pradesh) and circulated to ZPs/KPs/GPs. The department has also formed Performance Assessment Committees at state level ,divisional level and district level namely SPPAC, Div.PPAC and Distt.PPAC for assessment of the performance based on the filled questionnaires and committee recommendations. The respective committees at District, Divisional and State will furnish their recommendations regarding Panchayats that are to be given awards by MoPR following detailed procedure and using approved state-specific indicators, questionnaire and marking scheme. The field verification teams to be selected by DoPR are required to verify the data/information based on which these recommendations have been made after making field visits to these Panchayats

2. Objectives of the Scheme:

The Scheme aims to:

- a. Incentivize the States to empower Panchayats through devolutions of 3Fs (Function, Funds and Functionaries) in accordance with Article 243G read with eleventh schedule of constitution.
- b. Incentivize Panchayats to put in place accountability systems to make their functioning transparent and efficient.

3. SCOPE OF WORK:

Department of Panchayati Raj, GoUP proposes to engage agencies for conducting field visits to Panchayats across the States to verify the data/information furnished regarding the selected Panchayats. The number of Panchayats to be given awards is at Annexure-I.

The organization applying must be prepared to cover a minimum of 40 Panchayats and provide the requisite number of teams. Roughly, 20 teams of 40 persons would need to undertake field visits. These teams will be given training by DoPR before they undertake field visits.

The teams are expected to verify the data and/or the factual information with regard to the Panchayats recommended by the respective Committees for awards and ascertains the correctness of the same and furnish a report to DoPR. The methodology would be as under:

- (i) Each GP/KP/ZP recommended/shortlisted for awards by the divisional/district committees would be visited by a team of two persons after giving prior notice to them.
- (ii) Data/information in the questionnaire would be verified for factual accuracy with reference to the records maintained in the respective Panchayat. Discrepancies, if any, could be discussed with the concerned tier of Panchayat.
- (iii) Discussions would be held with GP/KP/ZP members and other stakeholders like residents, NGOs etc, if required.
- (iv) A report will be submitted to DoPR within a week from the date of visit.

4. COMPOSITION OF FIELD VERIFICATION TEAMS & OTHER REQUIREMENTS:

One team of 2 persons will cover roughly 5 PRIs. All the members of the team should have qualifications as stated below, good communication skills in Hindi and at least one team member should have experience of at least 2 years in the area of Panchayat. Preference will be given to those having experience of conducting field-based survey and training to elected Panchayat representatives/functionaries.

5. ELIGIBILITY OF APPLYING AGENCY:

The Agency needs to have sufficient capability to provide services for the work as specified above with adequate and competent manpower and infrastructure including computers and software required for the job. Since the task is time-bound, the Agency would be required to adhere to the prescribed timelines and work in close coordination with the DoPR. The field verification would be undertaken during December 2012.

Essential:

- 1. The agency must be Government, Government Undertaking or Government Research Institutes/ Educational Institute or Government Training Institutes of Uttar Pradesh or Govt. of India.
- 2. The Agency must be in a position to undertake field verification in at least 40 Panchayats in Uttar Pradesh.
- 3. The persons engaged by the agency for conducting field visits should be: (i) at least graduates from a recognized University; (ii) have good communication skills (oral & written) Hindi and (iii) have at least 2 years experience of working in the area of Panchayats functioning.

Desirable :-(i) Experience of field based survey; and (ii) experience of imparting training to the elected representatives/functionaries of Panchayats.

6. QUANTUM OF WORK:

The tentative number of Panchayats to be visited is given at Annex-I. The number of field visits may be increased/ decreased as per need.

7. SELECTION CRITERIA FOR THE AGENCY TO BE ENGAGED IN VERIFICATION UNDER PEAIS

The agencies will be evaluated by a Selection Committee constituted by DoPR in accordance with the selection criteria laid down hereunder. The Department may select one or more numbers of agency as may be desirable to complete the process of field verification in the specified time limit.

Following will be the criteria for the selection of the Agency.

❖ Selection Criteria

- a) Qualification & Experience of Agency.
- b) Previous experience of agency of working with Panchayats.
- c) Previous experience of agency of field verification visits.
- d) No. of teams available for field verification.
- e) Presence in State in terms of field office etc.

- f) No. of professionals on rolls of agency.
- g) Qualification and Experience of the Team member proposed for the verification (each member wise).

8. Support to be provided by DoPR

Following documents / inputs will be provided by Department of Panchayati Raj, GoUP:

- Training of State Field Verification Teams. (Annexure- III)
- A copy of guidelines of PEAIS.
- A copy of approved State specific indicators, questionnaire and marking scheme.
- Recommendations made by the State concerned for awarding Panchayats, as may be appropriate.

Any other relevant information as may be sought by the agency.

9. Fee:

DoPR will pay the agency for field visits as follows:

- (i) TA to field verification team will be admissible to either 2nd AC or below class train fare or in case of travel by road, hire charge for non-AC vehicle. Road journey preferably be performed by public transport entitled.
- (ii) Cost of Stay in the field will not exceed Rs.1000/- per person per day or Actual whichever is less.
- (iii) Honorarium of Rs.2000 per person per Panchayat (Calculated Rs. 1000/- per day per Panchayat for 2 days).

Note

- After the submission of the verification report by the Agency to the DOPR, the payment will be made to the Agency with in the 10 days after the receipt of the bills.
- DoPR would not be liable for any payment to agencies Team member payment of any way of any type.

10. DELIVERABLES:

The agency will be expected to deliver the following:

- 1. Verification of data/information as provided by PRIs and submission of the same.
- 2. Submission of hardcopy of verification report.
- 3. Submission of hard copies of coloured photographs for each Panchayat showing the Following:
 - a) Panchayat office, PRI members and survey team during the visit
 - b) Places visited in the relevant Panchayat.
 - c) Functionaries/elected PR representatives/NGO/Govt. Official of the dept. of Panchayati Raj or other stake-holders interacted with.
 - d) Records of Panchayats visited for field verification.

4. Recommendations

11. Project Timeliness

The Agency has to finish all work including site inspection by teams, preparation & submission of report of the visited/inspected PRIs within **20 days** from the date of the award of the work order.

12. SUB-CONTRACTING OF WORK:

Subcontracting of the work or part thereof awarded under these terms of contract will not be permitted in any form. Subcontracting will lead to termination of contract in addition to any other suitable actions for violation of ToR.

13. Penalty

In case the successful applying agency fails to complete the work within the prescribed time schedule or in case the delay is such that it seriously hampers the declaration of prizes, DoPR may take appropriate action against such agency.

14. Application and submission procedure

In the event of any discrepancy, the "Original" version shall govern. 15. OPENING AND EVALUATION OF PROPOSAL:
